
Our finances

Figure 1: Overall spending this year




Money from papers

Director income


The amount of money donated by our Director has increased slightly.





The number of sign-ups includes newsletters, memberships, and network subscriptions.


Figure 4: Sign-ups




We use the gender that an individual has asked to be referred to by on our team page.

The gender breakdown of our team members is based on the pronouns listed on our team page, which are provided to us by members of our team when they join.


Figure 7: Team gender breakdown

The gender breakdown of our administration team.


Figure 8: Administration gender breakdown


Figure 9: Spokespeople gender breakdown




Figure 11: Website views




